The panel will be formed strictly in the order of merit. The standard of the written examination under GDCE shall be that prescribed for Direct Recruitment Quota on open competition for this post.


9. Only those candidates who secure the requisite qualifying marks in the written examination are eligible to be empanelled for appointment as Junior Clerk-cum-Typist on the basis of the marks obtained in the written/Online examination, They should also be fit in the prescribed Medical Classification of CEE-ONE for Junior Clerk-cum-Typist before they are appointed.

10. The final empanelment for the vacancies notified would be as per eligibility & merit.
