7. Selection Mode:

Personal Interview. The management at its discretion may change the mode of selection if required.

8. Duration of Contractual Engagement:

The contract period is initially for 15 (fifteen) months.

9. General Conditions :

- a. The candidates must have an active e-mail id and mobile number, which must remain valid for at least next one year. All future communication with the candidates will take place through registered email id only.
- b. Candidates are advised to carefully read the full advertisement for details of educational qualification and other eligibility criteria before submission of on-line application.
- c. Reservation and relaxations for SC/ST/OBC (non-creamy layer)/PwD(Person with Disability) & Ex-servicemen(ESM) candidates shall be as per Government of India guidelines.
In case of a candidate who is eligible for relaxation under more than one of the above categories, the age relaxation will be available on cumulative basis subject to maximum of 46 years (for post no. 1 & 6); 45 years (for post no. 5, 7 & 8) and 40 years (for post no. 2, 3 & 4).
